

12 Farm Safety Resource Kit for Nova Scotia Farmers

Occupational Health and Safety Act

The Occupational Health and Safety Act is designed to improve workplace health and safety. It applies to all workplaces, including farms, regardless of the number of people employed. The Internal Responsibility System is the foundation of the Act, in which everyone in the workplace shares responsibility for making the workplace safer and healthier, taking every reasonable precaution to prevent accidents.

"Your Rights, Responsibilities, and the Occupational Health and Safety Act" is a guide describing some of the main points covered in the Act, and what they mean to *employers*, *employees*, *contractors*, *constructors*, *and self-employed persons* at the workplace. Society of Farm Safety Nova Scotia

In November 2009, with assistance from the Canadian Agricultural Safety Association, the Nova Scotia Federation of Agriculture initiated the establishment of a farm safety organization in Nova Scotia. A review of safety organizations in other industry sectors in Nova Scotia and changes to the provincial *Occupational Health and Safety Act* confirmed the need to have a central organization solely devoted to delivering health and safety support to the agriculture community.

The Society of Farm Safety Nova Scotia can assist in the development of your Farm Health and Safety Plan. The Society assists farmers to identify and act on the safety hazards present on the farm by:

- conducting a Farm Safety Assessment with the farmer;
- helping develop a farm safety action plan to address the hazards;
- providing safety information, safe work practices and safe job procedures;
- advising on and helping access required training programs;
- assisting the agricultural community navigate government regulations;

Training

There are basic training requirements under the *Occupational Health and Safety Act* for every workplace in Nova Scotia, which include an introduction to the Act, WHMIS and first aid. The number of employees and the distance from a health care facility may dictate the level of first aid certification required and require the preparation of remote location plans. In addition, there may be more specific training requirements based on specific job tasks and the workplace environment. Please consult the *Occupational Health and Safety Act* and the appropriate regulations.
